In the past year these included support for the local St. Vincent de Paul group, the South Windsor CT Food Bank and Human Services department, Carter Cares Inc., 5 South Windsor high school seniors with scholarships, the South Windsor American Legion in Wreaths Across America and their fallen heroes program for veterans in town, a Military Appreciation Dinner, the South Windsor Community Chorus, and a shelter in East Hartford CT.

Faith: One of our key activities is to support our parish and activities that strengthen our Catholic faith. We supported a variety of different activities this year, including support for three people pursuing their religious calling (our RSVP program). We also provided the cost for a person to attend a retreat that the person could not otherwise attend, a poster contest to "Keep Christ in Christmas", several activities related to our own parish (an ice maker for the church hall, gifts to First Communion recipients, Mothers Day flowers for all parish Moms, an Easter Egg hunt, our Parish golf tournament, a local retreat center's youth religious programs, and a local church's fund-raising efforts (not our own parish).

Family: Programs we support here help out youth programs and strengthening of family. This year we provided support for the Special Olympics, a parishioner's daughter with Type 2 diabetes needing help with tuition to a special summer camp for children learning to cope with this disease, and our annual Coats for Kids drive in the late fall.

Part III, line 4d: our Life activities support included a donation to the group operating a mobile ultrasound van for use in remote parts of Connecticut and a donation to St. Gerard's Center in Hartford for use in operation of and training for its ultrasound facility.

Part VI, lines 6, 7a, 7b: Our local Council has 187 paid Brother Knights, or members. We elect officers once per year (in June), but all fiscal decisions are made by the Council at scheduled monthly meetings. The officers cannot spend over \$200 without approval of the full council at a planned meeting (per by-laws). Thus the governing body is the membership, not the officers (from a financial perspective).

Part VI, line 11b: This is the first time we have filed the full Form 990; we had used 990-EZ in the past. This is being reviewed by our Treasurer and Financial Secretary, and by our new Grand Knight, before filing, as was the case with 990-EZ in the past.

Part VI, line 19: While not a secret, our Council's financial statements are normally only of interest to our national Knights of Columbus organization. Self-audits are required twice per year by the national organization, and these are filed on time by our Council. While this form is not planned for review by the full council, our annual budget is reviewed for approval in September each year, and periodic updates are provided at full Council meetings. Governance rules are laid out in the Council by-laws document, which every member has a copy of. The conflict of interest policy is laid out clearly in the by-laws.
