At least 14 scholarships were provided to needy students during 2019. Approximately 417 children were provided assistance in 2,764 sessions at the Monroe-Meyer Institute in 2019. The governing body consists of citizens from Omaha and Ralston, NE and Council Bluffs, IA. Widespread support of this organization is accomplished in a multi-county area of Eastern Nebraska and Western Iowa. Six of the nine board members are elected yearly. Two board members serve one year terms and four board members may be re-elected up to three years. The final three members are appointed by the Cathedral Board. These appointments may be but not necessarily are a member of the Cathedral Board. At least 13 scholarships were provided to needy students during 2018. Approximately 342 children were provided assistance in 3,186 sessions at the Monroe-Meyer Institute. The governing body consists of citizens from Omaha and Ralston, NE and Council Bluffs, IA. Widespread support of this organization is accomplished in a multi-county area of Eastern Nebraska and Western Iowa. Six of the nine board members are elected yearly. Two board members serve one year terms and four board members may be re-elected up to three years. The final three members are appointed by the Cathedral Board.
