GRANTS OF 45,000 WERE AWARDED TO PUBLIC SCHOOL DISTRICTS TO PURCHASE TECHNOLOGY AND OTHER MATERIALS. THE ANIMAL FUND SUPPORTS PROGRAMS THAT PROVIDE CARE AND PROTECTION OF ANIMALS IN WASHINGTON COUNTY. THE ACORN FUND SUPPORTS EMERGING AND UNMET NEEDS IN THE COMMUNITY.
