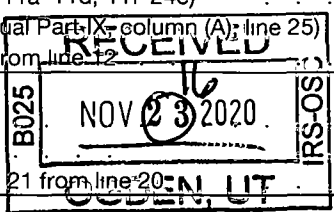

The Beth C. Wright Center offers a variety of programs and services for people living with cancer in Hancock and Washington counties in Maine. These programs are also offered to family members, caregivers, and friends of people diagnosed with cancer and also to interested community members. All of these programs are offered at no charge at our Center in Ellsworth and other locations in Hancock and Washington counties. These programs include classes in reiki, yoga, therapeutic exercises, reflexology, and other complementary therapies. The Center also facilitates support groups for people living with cancer in Ellsworth and other communities in Down East Maine. The Center also started an online support group this year attended by people at their own home to overcome the barrier of long distances required to travel in a rural community to some of our programs. Working with other community partners the Beth C. Wright Center organizes the Washington County Cancer Conference in Machias and the Down East Living With Cancer Conference in Bar Harbor. The Beth C. Wright Center in collaboration with Healthy Acadia continues to offer the Downeast Cancer Patient Navigation Program that provides one-on-one support to a cancer patient living in Washington County to help that patient overcome barriers to treatment and also to provide emotional and resource support. The Center working through the volunteer efforts of Donna Wieggle, an ovarian cancer survivor, promoted awareness of the symptoms of ovarian cancer.

This total is the portion of the Executive Director's salary and the salary of the part-time Program / Volunteer Coordinator that is devoted to programs. The Executive Director is involved in recruiting instructors for programs, facilitating support groups, and telling people living with cancer about the programs and services of the Beth Wright Center. He is also a member of the planning committees for the Washington County Cancer Conference and the Down East Living With Cancer Conference. The Program / Volunteer Coordinator manages the volunteer program of the Center. She is also responsible for new program development and the coordination of existing programs at the Center. She is also responsible for organizing the outreach programs in different towns in Hancock and Washington counties. She recruits, trains, and supervises the volunteers who lead the many programs of the Beth Wright Center.

The Beth C. Wright Center awarded grants of up to 250.00 for the most part an on occasions more to people living with cancer to help them cope with the financial stresses that are the results of going through treatment for cancer. Many of these grants were to reimburse people for some of their costs incurred traveling the long distances required to their cancer treatments. Grants were also awarded to help people pay for household bills such as heating bills, mortgage payments, rent, or car payments and repairs.
