THE TULALIP FOUNDATION WAS AWARDED A GRANT OF \$71,445.00 FROM THE BUREAU OF INDIAN AFFAIRS, OFFICE OF TRUST SERVICES UNDER THE TRIBAL RESILIENCE PROGRAM TO ENHANCE THE TULALIP TRIBES' CAPACITY TO ADDRESS EXTREME EVENTS AND HARMFUL ENVIRONMENTAL TRENDS. THE PLANNING TEAM IS LED BY THE TRIBES' CONSERVATION SCIENTIST AND INCLUDES STAFF FROM THE TULALIP FOUNDATION, THE TREATY RIGHTS OFFICE, THE NATURAL RESOURCES DEPARTMENT, THE DEPARTMENT OF EDUCATION AND INNOVATION, THE PLANNING DEPARTMENT, AND THE COMMUNICATIONS DEPARTMENT. THE PLANNING TEAM WILL WORK TOGETHER TO DEVELOP AND DELIVER CULTURALLY FOCUSED WORKSHOPS, WHICH WILL CONTINUE TO BUILD TRIBAL RESILIENCE THROUGH ENHANCING TULALIP TRIBAL LEADERSHIP AND MEMBERSHIP'S UNDERSTANDING ABOUT THE ENVIRONMENTAL CHANGES CURRENTLY BEING EXPERIENCED ON THE TULALIP INDIAN RESERVATION, BUILDING ON THE INSIGHTS TO INFORM THE TULALIP TRIBES' STRATEGIES TO ADAPT TO THOSE CHANGES, AND INCREASING CAPACITY FOR ALL TO ADVOCATE FOR AND IMPLEMENT ENVIRONMENTALLY SUSTAINABLE PRACTICES. AS THE PROJECT GOT UNDERWAY IN THE SECOND HALF OF 2019, THE PLANNING ADMINISTERED A COMMUNITY SURVEY TO DETERMINE COMMUNITY INTERESTS AND LEVELS OF UNDERSTANDING AND BEGAN TO ENGAGE WITH A CONSULTANT ON THE DEVELOPMENT OF AGE APPROPRIATE CURRICULUM TO BE UTILIZED IN LOCAL SCHOOLS.

THE TULALIP FOUNDATION CONTINUED TO PARTNER WITH THE HIBULB CULTURAL CENTER (HCC) TO ON A DONATION CAMPAIGN IN SUPPORT OF THE HCC'S VISION OF "KEEPING THE CULTURAL FIRES BURNING." THROUGH THEIR FINANCIAL GIFTS, TRIBAL MEMBERS, TRIBAL EMPLOYEES, AND COMMUNITY MEMBERS CONTRIBUTED TO THE LEGACY OF HIBULB CULTURAL CENTER, SUPPORTING ITS MISSION TO KEEP THE CULTURAL FIRES BURNING AND PROVIDING A FOUNDATION FOR LIFE-LONG LEARNING. IN TOTAL, THE GREATER TULALIP COMMUNITY DONATED OVER \$7,700 FOR THE BENEFIT OF HCC EDUCATION, CONSERVATION, CULTURAL RESOURCES, ROTATING EXHIBITIONS, AND THE NATURAL HISTORY PRESERVE.

THE TULALIP FOUNDATION WAS HONORED TO BE CHOSEN AS ROY ROBINSON SUBARU'S HOMETOWN CHARITY FOR THE 2018 SUBARU SHARE THE LOVE EVENT, WHICH RAN FROM NOVEMBER 15, 2018 TO JANUARY 2, 2019. DURING THE EVENT, SUBARU MADE A DONATION FOR EVERY NEW VEHICLE SOLD OR LEASED DURING THE EVENT TIMEFRAME TO THE PURCHASER'S CHOICE OF FOUR NATIONAL CHARITIES OR A LOCAL HOMETOWN CHARITY. AS A RESULT, THE ORGANIZATION RECEIVED A GENEROUS DONATION OF OVER \$21,000, WHICH IT THEN SHARED WITH SOME OF ITS COMMUNITY PARTNERS.
