During 2019, a component fund within the MASSB Foundation provided the following services for Washington County, Maryland's vulnerable or at-risk children, adults, and families: (1) operation of the Sunshine Center for Family Visitation focused on providing family reunification and parental training for families separated for child protection purposes, (2) transportation to and from the Family Center for job training and family counseling, (3) clothing and education-related supplies, (4) emergency housing and utility assistance, and (5) transportation assistance for medical or other assistance for those in need

During 2019, a component fund within the MASSB Foundation provided the following services for Charles County, Maryland's Charles County expenditures helped fund specific programs that supported 1) visitation of children in foster care with their parents at the Clifford House, our visitation house. This house is outfitted with supplies needed to support parents in visiting with their children in a "natural" home environment

Funds were also used to provide a day-long convening of parents, the community and child welfare partners to understand the role of trauma in the lives of those served through the child welfare system. This convening focused on explaining how trauma occurs for those involved in the CWS and discussed ways the community can better address those affected by trauma
