James Sanderson is a member of the review board for MbZSCF that awards grants to species conservation projects globally.

James reviews all wild cat conservation proposals 3 times a year for MbZSCF. The MbZSCF small wild cat conservation budget was \$96,600 in 2017. In addition to the MbZSCF budget Small Wild Cat Conservation Foundation contributed \$11,367 to support more small cat conservation projects.

(1) The Mohamed bin Zayed Species Conservation Fund (MbZSCF) wild cat budget is \$96,600 annually. In 2019, MbZSCF provided \$107,967 to support various wild cat conservation projects worldwide. As part of the review team Small Wild Cat Conservation Foundation (SWCCF) supports many small wild cat projects globally using MbZSCF funding. When a shortfall arises SWCCF makes up the difference. In 2019, SWCCF provided \$11,367 to MbZSCF to support wild cat conservation projects. This is a leverage of 8.5:1.

(2) The cost of attending the MbZSCF review team meetings in 2019 was \$4,292.22.

(3) In addition to support from MbZSCF, SWCCF's two fishing cat conservation projects in Sri Lanka required \$6,896.22 that includes travel.

(4) In addition to support from MbZSCF, SWCCF's conservation program for tigrina in Costa Rica required \$1,949.35 including travel costs.

(5) To investigate the status of African golden cat in Sierra Leone cost \$3,339.01 including travel costs.

(6) To attend meetings, present professional talks, and to provide camera trap data processing workshops cost \$12,590.85.

(7) To investigate the status of the Bakhuis mountain wildlife in Suriname cost \$2,677.90.

(8) Book preparation costs including printing & obtaining an ISBN totalled \$6,902.76. Donations to support the book exceeded costs.

(9) To attend fundraising events cost \$1,256.68

(10) Annual California tax forms required payments of \$10 (Franchise Tax Board), \$75 (Registry of Charitable Trusts), and \$20 (Secretary of State) totalling \$105.00.

(11) Overhead costs including phone, internet, passport renewal, office equipment, website, and miscellaneous totalled \$17,452.54.

(12) There were unpaid costs from 2018, and all costs incurred in 2019 were paid in full.
