Reasonable Cause Explanation

Taxpayer, Fair Havens Ministries, Inc (an exempt organization) in response to your letter (LTR 2694C), dated January 28, 2021, is asking for penalty abatement based on reasonable cause under Regs. Sec. 301.6652-1(f).

The reason the penalty is being charged is due to filing an incomplete return by leaving Schedule O out of the filing of the original return.

Circumstances that lead to erroneously leaving off the Schedule O fall on the shoulders of the preparer. Software issues related to our non-profit returns prevented the accountant from being able to file the return electronically on 2019 returns. This caused the accountant to have to file the return by conventional paper methods. The Schedule O was prepared originally and meant to be attached to the original return but did not make it through the printing process.

We humbly apologize for this accidental error during the assembly of the original return. The omission was not due to willful neglect. The omission was due solely in error during assembly of the return

We received the rejection letter dated January 28, 2021 and quickly resolved the issue. The return is being resubmitted within the 10 days requested by the Internal Revenue Service. The taxpayers exercised ordinary business care and prudence in resolving this matter

The Accountant has already taken steps to deal with software issues that were raised during the 2019 tax filing deadline. We have spoken with the software company to fix the issues that caused this return to have to be paper filed resulting in the Schedule O being left off the original return.

We ask that you abate the penalties due from filing the Form 990 incomplete due to the circumstances being accidental in nature and not due to willful neglect. The taxpayer followed all ordinary business care and prudence in clearing the matter at hand in the time frame afforded by the Internal Revenue Service
