Explanation: Burnt Oranges is an all volunteer organization in which our Officers and Board are typically available for 5 hours a week for organizational responsibilities. The organization also receives all operating funds from community donations and a semi-annual event. For 2020, the new Board chose to bring on a volunteer accountant to save money for preparing our Annual Reports (including filing our 2019 taxes). Unfortunately, the timing of this decision occurred at the same time of the arrival of the COVID-19 pandemic which resulted in both our Volunteer Board Members and Accountant available hours to drastically decrease as their focus had to shift to their regular jobs and family. It is the unforeseen fallout of the COVID-19 pandemic that has resulted in the delay in the organization filing their 2019 taxes.
