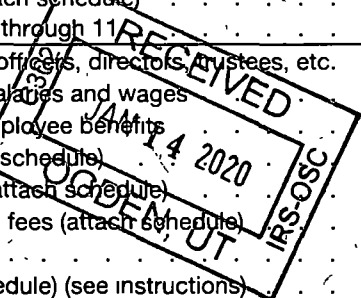

**Part X, Line 4: Cash Deemed Held for Charitable Activities, Explanation of Amount Larger Than 1½%**

Firkin Press has no investments and operates solely from cash contributions and revenue from the sale of electronic book versions of the organization's literary magazine. In 2019 our average monthly total of contributions plus revenues was \$3,531. Our beginning-of-year Cash balance in 2019 was \$2,780. Thus, our total monthly amount of Cash for 2019 averaged \$3,763 (\$3,531 average contributions & revenues per month, plus the \$2,780 beginning-of-year balance divided by 12 months in the year: \$232 average per month). Our average monthly expenses for carrying out our routine charitable activities in 2019 were \$3,621. This results in an average surplus of \$142 per month (\$3,763 average monthly Cash minus \$3,621 average monthly expenses). Thus, from the \$2,666 average end-of-month balance calculated for 2019, we consider a cash amount of \$2,524 (\$2,666 average monthly balance minus \$142 average monthly surplus) held for our charitable activities.
