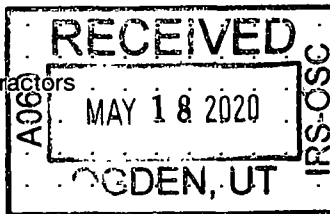

Part III - Malawi Matter Inc is a 501(c)(3) not-for-profit organization with a United States based all volunteer board of directions and staff whose mission is to develop and facilitate HIV/AIDS education with the people of Malawi and Central Africa and to educate Malawian and Central African women for life improvement. Malawi Matters Inc uses proven techniques utilizing local arts and learning methods grounded in Malawina culture ato find solutions to the HIV/AIDS crisis and improving the communitites so impacted by supporting the life improvement of local women and female youth. In 2019 Malawi Matters Inc continued to expand the delivry of these education methods in this economically impoverished, but spiritually rich nation by finalizing the formation of a Non-Govermental Organization (NGO) in Malawi and by assisting the Malawian led NGO to work with the agencies, organizations and communities to further the HIV/AIDS education in that country.
