SECOND: Article I of the Articles of Incorporation of the Corporation shall be deleted in its entirety and the following substituted in lieu thereof:

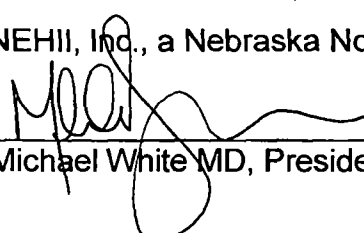
"ARTICLE I
