The undersigned, a citizen of the United States, pursuant to Title 13.1, Chapter 10, Article 10 of the Code of Virginia, states the following as and for the Amended and Restated Articles of Incorporation of IN BETWEEN THE LINES, INC.:

ARTICLE 1

6.1 The Corporation shall be a nonprofit corporation. federal tax laws, all within the meaning of § 501(c)(3) of the *Internal Revenue Code of 1986*, as amended, or the corresponding section of any subsequent federal tax laws, including any current or future Regulations, Revenue Rulings, Revenue Procedures, and other federal tax law promulgated under § 501(c)(3) of the *Internal Revenue Code of 1986*, as amended, or the corresponding section of any subsequent federal tax laws; including, for such purposes, the making of distributions to organizations that qualify as exempt organizations under § 501(c)(3) of the *Internal Revenue Code of 1986*, as amended, or the corresponding section of any subsequent federal tax laws, including any current or future Regulations, Revenue Rulings, Revenue Procedures, and other federal tax law promulgated under § 501(c)(3) of the *Internal Revenue Code of 1986*, as amended, or the corresponding section of any subsequent federal tax laws.

6.2 Among the Corporation's charitable purposes are (i) providing workforce training to youth and young adults, focusing on disadvantaged youth who would not be able to participate in workforce training programs if they did not receive financial support; (ii) empowering youth and young adults, focusing on disadvantaged youth, to enter the workforce; (iii) training youth and young adults, focusing on disadvantaged youth, in the construction trades, including training as carpenters, drywall installers, plumbers, electricians, roofers, and heating, ventilation and air conditioning technicians; and (iv) training youth and young adults, focusing on disadvantaged youth, in the construction trades by deconstructing and constructing improvements to real property.

6.3 As a means of accomplishing the foregoing purposes, the Corporation shall have the power to do any and all acts as are necessary or conducive to the attainment of any of the objects and purposes hereinbefore set forth, to the same extent and as fully as any natural person might or could do; provided, however, that notwithstanding any provision of these Amended and Restated Articles of Incorporation or any provisions of applicable state law to the contrary, the Corporation shall not have the power to carry on any activities which would cause it to fail to qualify, or to continue to qualify, as (a) an organization exempt from Federal income tax under § 501(c)(3) of the *Internal Revenue Code of 1986*, as amended, or the corresponding section of any subsequent federal tax laws, including any current or future Regulations, Revenue Rulings, Revenue Procedures, and other federal tax law promulgated under § 501(c)(3) of the *Internal Revenue Code of 1986*, as amended, or the corresponding section of any subsequent federal tax laws; or (b) an organization contributions to which are deductible under §§ 170, 2055, and 2522 of the *Internal Revenue Code of 1986*, as amended, or the corresponding section of any subsequent federal tax laws, including any current or future Regulations, Revenue Rulings, Revenue Procedures, and other federal tax law promulgated under § 501(c)(3) of the *Internal Revenue Code of 1986*, as amended, or the corresponding section of any subsequent federal tax laws.

6.4 The Corporation shall be authorized to solicit, receive, and administer funds for the above purposes, but the Corporation shall not be authorized to accept gifts or contributions for other than the purposes hereinbefore stated. The funds of the Corporation shall not be restricted in use to people of any race, color, sex, national origin, religion, marital status, disability, sexual

orientation, veteran status or creed, but such funds shall be administered on a nondiscriminatory basis.

ARTICLE 7

7.1 No part of the net earnings of the Corporation shall inure to the benefit of, or be distributable to its directors, officers, employees, or other private persons, except that the Corporation shall be authorized and empowered to pay reasonable compensation for services rendered and to make payments and distributions in furtherance of the purposes set forth in Article 6 above.

7.2 No substantial part of the activities of the Corporation shall be the carrying on of propaganda, or otherwise attempting to influence legislation, and the Corporation shall not participate in, or intervene in (including the publishing or distribution of statements) any political campaign on behalf of or in opposition to any candidate for public office. 8.1 Notwithstanding any other provisions of these Amended and Restated Articles of Incorporation, the Corporation shall at all times operate and conduct its activities in a manner that it shall qualify as a public charity within the meaning of § 509(a)(2) of the *Internal Revenue Code of 1986*, as amended, or the corresponding section of any subsequent federal tax laws, including any current or future Regulations, Revenue Rulings, Revenue Procedures, and other federal tax law promulgated under § 509(a) of the *Internal Revenue Code of 1986*, as amended, in that the Corporation qualifies as normally receiving not more than one-third of its support from gross investment income and more than one-third of its support from contributions, grants, and gross receipts from activities related to its exempt functions (subject to certain exceptions).

ARTICLE 9

9.1 Notwithstanding Article 8 above, if, at any time or times, the Corporation shall be classified as a private foundation under United States Internal Revenue laws, then at such time or times the Corporation shall be subject to the following restrictions:

(a) The Corporation shall not engage in any act of self-dealing as defined in § 4941(d) of the *Internal Revenue Code of 1986*, as amended, or the corresponding section of any subsequent federal tax laws, including any current or future Regulations, Revenue Rulings, Revenue Procedures, and other federal tax law promulgated under § 4941(d) of the *Internal Revenue Code of 1986*, as amended, or the corresponding section of any subsequent federal tax laws.

(b) The Corporation shall distribute its income for each taxable year at such times and in such manner as not to become subject to the tax on undistributed income imposed by § 4942 of the *Internal Revenue Code of 1986*, as amended, or the corresponding section of any subsequent federal tax laws, including any current or future Regulations, Revenue Rulings, Revenue Procedures, and other federal tax law promulgated under § 4942 of the *Internal Revenue Code of 1986*, as amended, or the corresponding section of any subsequent federal tax laws.

(c) The Corporation shall not retain any excess business holdings as defined in § 4943(c) of the *Internal Revenue Code of 1986*, as amended, or the corresponding section of any subsequent federal tax laws, including any current or future Regulations, Revenue Rulings, Revenue Procedures, and other federal tax law promulgated under § 4943(c) of the *Internal Revenue Code of 1986*, as amended, or the corresponding section of any subsequent federal tax laws.

(d) The Corporation shall not make any investments in such manner as to subject it to tax under § 4944 of the *Internal Revenue Code of 1986*, as amended, or the corresponding section of any subsequent federal tax laws, including any current or future Regulations, Revenue Rulings, Revenue Procedures, and other federal tax law promulgated under § 4944 of the *Internal Revenue Code of 1986*, as amended, or the corresponding section of any subsequent federal tax laws.

(e) The Corporation shall not make any taxable expenditures as defined in § 4945(d) of the *Internal Revenue Code of 1986*, as amended, or the corresponding section of any subsequent federal tax laws, including any current or future Regulations, Revenue Rulings, Revenue Procedures, and other federal tax law promulgated under § 4945(d) of the *Internal Revenue Code of 1986*, as amended, or the corresponding section of any subsequent federal tax laws.

ARTICLE 10

10.1 The Corporation does not have any capital stock. The Corporation is a nonstock nonprofit corporation. The Corporation shall not be authorized to issue capital stock.

ARTICLE 11

11.1 The affairs and business of the Corporation shall be managed and conducted by the Board of Directors. The qualifications, election, number, tenure, powers, and duties of the members of the Board of Directors shall be as provided in the Bylaws. The Board of Directors may, by a majority of the whole Board, elect Officers of the Corporation to serve at the pleasure of the Board of Directors. The qualifications, election, number, tenure, powers, and duties of any such Officers shall be as provided in the Bylaws. The Board of Directors may, by a majority of the whole Board, designate one or more Committees to serve at the pleasure of the Board of Directors. The qualifications, election, number, tenure, powers, and duties of such Committees and the members of the Board of Directors serving on such Committees shall be as provided in the Bylaws.

ARTICLE 12

12.1 No member of the Board of Directors of the Corporation, or Officer of the Corporation shall be personally liable for the payment of the debts of the Corporation except as such Director or Officer may be liable by reason of his or her own conduct or acts.

ARTICLE 13

13.1 A Director of the Corporation shall not be personally liable to the Corporation for monetary damages for breach of fiduciary duty as a Director, except for liability (a) for any breach of the Director's duty of loyalty to the Corporation, (b) for acts or omissions not in good faith or which involve intentional misconduct or a knowing violation of law, (c) under § 13.1-870 of the VIRGINIA NONSTOCK CORPORATION ACT, or (d) for any transaction from which the Director derived any improper personal benefit. If the VIRGINIA NONSTOCK CORPORATION ACT is amended after approval by the Board of Directors of this Article to authorize Corporation action further eliminating or limiting the personal liability of directors, then the liability of a Director of the Corporation shall be eliminated or limited to the fullest extent permitted by the VIRGINIA NONSTOCK CORPORATION ACT as so amended. Any repeal or modification of the foregoing provisions of this Article 13 by the Board of Directors of the Corporation shall not adversely affect any right or protection of a Director of the Corporation existing at the time, or increase the liability of any Director of this Corporation with respect to any acts or omissions of such Director occurring prior to such repeal or modification.

ARTICLE 14

14.1 To the fullest extent permitted by applicable law, this Corporation is also authorized to provide indemnification of (and advancement of expenses to) Directors, Officers, and other agents (and any other persons to which Virginia law permits this Corporation to provide indemnification) through Bylaw provisions, agreements with such Directors, Officers, other agents or other persons, vote of disinterested Directors or otherwise, in excess of the indemnification and advancement otherwise permitted by the VIRGINIA NONSTOCK CORPORATION ACT, subject only to limits created by applicable Virginia law (statutory or non-statutory), with respect to actions for breach of duty to this Corporation by its Directors, its Officers, its other agents, and others. Any repeal or modification of any of the foregoing provisions of this Article 14 shall not adversely affect any right or protection of a Director, Officer, other agent, or other person existing at the time of, or increase the liability of any Director or Officer or other agent of this Corporation with respect to any acts or omissions of such Director, Officer or other agent occurring prior to such repeal or modification.

ARTICLE 15

15.1 In the event of the liquidation, dissolution, or winding up of the affairs of the Corporation, whether voluntary, involuntary, or by operation of law, the Board of Directors of the Corporation shall, except as may be otherwise provided by law, transfer all of the assets of the Corporation in such manner as the Directors, in the exercise of their discretion, may by a majority vote determine; provided, however, that any such distribution of assets shall be calculated to carry out the objects and purposes hereinbefore stated in Article 6 hereof, and only such objects and purposes; and, provided further, that such distributions must be to (a) one or more organizations (i) which are exempt from Federal income tax under § 501(c)(3) of the *Internal Revenue Code of 1986*, as amended, or the corresponding section of any subsequent federal tax laws, including any current or future Regulations, Revenue Rulings, Revenue Procedures, and other federal tax law promulgated under § 501(c)(3) of the *Internal Revenue Code of 1986*, as amended, or the corresponding section of any subsequent federal tax laws; and (ii) contributions to which are deductible under §§ 170, 2055, or 2522 of the *Internal Revenue Code of 1986*, as amended, or the corresponding section of any subsequent federal tax laws, including any current or future Regulations, Revenue Rulings, Revenue Procedures, and other federal tax law promulgated under § 501(c)(3) of the *Internal Revenue Code of 1986*, as amended, or the corresponding section of any subsequent federal tax laws; or (b) to the federal government; or (c) to a state or local government, for a public purpose. Any such assets not so disposed of shall be disposed of by a court of competent jurisdiction of the county in which the principal office of the Corporation is then located, exclusively for such purposes, or to such organization or organizations, as such court shall determine, that are organized and operated exclusively for such purposes.

ARTICLE 16

16.1 In furtherance and not in limitation of the powers conferred upon the Board of Directors by law, the Board of Directors shall have the power to make, adopt, alter, or repeal, from time to time, the Bylaws of the Corporation.


ARTICLE 17

17.1 The Corporation reserves the right to amend, alter, or repeal any provisions contained in these Amended and Restated Articles of Incorporation in a manner now or hereafter prescribed by applicable statutes, and all rights conferred herein are granted subject to this reservation; provided, however, that no amendment shall authorize the Board of Directors to conduct the affairs of the Corporation in any manner or for any purpose contrary to the provisions of § 501(c)(3) of the *Internal Revenue Code of 1986*, as amended, or the corresponding section of any subsequent federal tax laws, including any current or future Regulations, Revenue Rulings, Revenue Procedures, and other federal tax law promulgated under § 501(c)(3) of the *Internal Revenue Code of 1986*, as amended, or the corresponding section of any subsequent federal tax laws.

ARTICLE 18

18.1 These Amended and Restated Articles of Incorporation were adopted on March 11, 2019, by unanimous consent of the Board of Directors. Member approval of these Amended and Restated Articles of Incorporation was not required because the Corporation has no members.
