Therefore, there was no need for a review and approval by independent persons, comparability data, and contemporaneous substantiation of the deliberation and decision to determine the process for determining compensation for the president of this organization. However, we did look at independent publications to see average salaries of the president's position and we were way under the average market salary price in the United States of America.
