sign a Memorandum of Understanding for the construction of each school building and the development of each school

site, which includes the number and amounts of funds that will be transferred, the monitoring and evaluation process

and clear expectations and responsibilities for our organizations. We transfer the funds to the partner Ecobank accounts

as directed in the memorandum of understanding. The process is similar for the Student Sponsorship Program. School

boards and directors document required information for the program.

In addition to visiting the school sites, we communicate by phone and email weekly with our partners, who

send us notice of receipt of funds, photos of projects and programs and reports. We maintain complete and accurate

records documenting the process and results of our programs and projects.

Remember Niger Coalition (RNC) is a 501(c)(3) non-profit organization dedicated to uniting people and mobilizing resources to expand quality educational opportunities in Niger, Africa. We are unique in that we partner with and support Nigerien organizations who have a remarkable vision for their country and share our core values. Through a holistic approach and by working side-by-side with our Nigerien partners, who own and operate their schools, we are able to ensure that more and more children receive a high-quality education in the least developed country in the world.

Our vision is that every child in Niger has access to a high-quality education, which will create opportunities for leadership roles in their communities and beyond. Through our work, we will reach a tipping point in Niger: When enough children have received a quality education, they will have an enormous impact on their communities and will positively transform their country.

Since 2009, we have grown from 3 school partners to 10 and from 300 students to 2,561.
