In 2019 VCF continued its support of center expansion in Latin America and North America with various grants and a loan to centers, as well as a general operating grant to the nonprofit organization, Pariyatti, in support of Pariyatti's pilgrimage program and pilgrimage partner organizations Grant to Asociacon Vipassana Argentina to support kitchen expansion at Dhamma Sukhada This center outside Buenos Aires serves approximately 1000 meditators and 300 servers per year A grant of \$35,000 was awarded to Dhamma Sukhada in May 2019 to improve and expand their kitchen and dining areas Existing facilities did not provide sufficient space for food preparation or storage Also, servers lacked dining areas and they had to go outside to bring food from the kitchen to the student dining rooms With this grant the Center constructed an adjacent building with walk-in refrigerator, food pantry, two server dining rooms and enclosed the space between the kitchen and student dining hall Grant funds were supplemented by funds from the Center and the project was completed in October 2019 Grant to Associao Vipassana do Brasil to support construction projects at Dhamma Santi The center is continuing to fulfill its master construction plan and to build out long course facilities A \$90,000 grant was awarded, by VCF in September 2019 to support the following projects more meditation cells for men and women, eight private rooms with attached bathrooms, a two-story building for servers, an additional collective bathroom for women and increased capacity for long course students from 44 to 60 Total cost is estimated at \$181,759 and will be funded primarily by savings and awareness outreach to old students The grant period is through September 15, 2021 Grant to Pariyatti to support operations and pilgrimage work in Burma A grant of \$98,000 was awarded in December 2019 to the U S -based nonprofit Pariyatti There were two components to the grant \$15,000 for general operating support and \$83,000 for general operating support for Pariyatti's pilgrimage program in Myanmar Pariyatti, a U S -based registered 501(c)(3) nonprofit organization, provides written and audio materials about Vipassana and the Buddha's teachings to meditators, scholars, educators and the general public Offerings include hard-to-find titles, a large collection of online resources, and Pali workshops Its pilgrimages to India, Myanmar (or Burma), and Nepal facilitate travel to places connected with the Buddha's teachings The grant period is for one year, ending December 15, 2020 Grant and Loan to Northwest Vipassana Association (Dhamma Kuja in Washington State) A grant of \$100,000 plus a loan of \$100,000 (totaling \$200,000) was made to Dhamma Kuja in Washington State for its Pagoda Fund from a VCF Donor Advised Fund and the New Revolving Loan Fund This center was established in 1991, the third in the United States Building a meditation cell complex has been part of the master plan for more than 20 years Design work and the loan application process were well underway when the Trust was informed that a personal guarantee for the \$4.1 million bank loan would be required Instead of continuing to pursue a commercial loan, Dhamma Kuja reached out to old students and VCF for grants and loans Phase 1 construction includes 71 cells, a small meditation hall and two interview rooms in a three-story building adjoining the existing meditation hall, work on this phase will be completed in 2020 The loan is scheduled to be repaid into the Revolving Loan Fund by 2029
