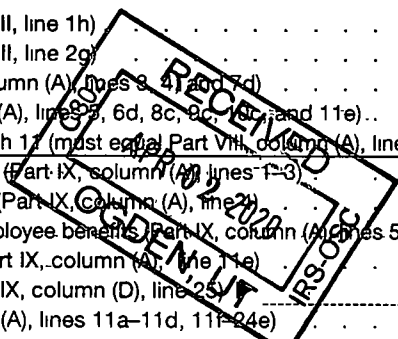

In community partnership with UC Berkeley, SOAR for Youth helps foster youth move through adolescence and into their adult lives with independence. Through a three-year summer residential pre-collegiate program and additional years of academic support, SOAR teaches, coaches, and counsels our young people (grade 6 - 2nd year in college) in academics, life skills, emotional intelligence and career development. The SOAR program aims to help our young people graduate from high school, attend college and succeed in life.

Summer Pre-Collegiate Academies (Previously Foster Youth Summer Program)

We partnered with Bay Area County Social Services and local CASA chapters to identify candidates for our program. We held three one week residential pre-collegiate academies (Prepare To SOAR; Learn To SOAR; Time To SOAR) on the UC Berkeley campus.

We served 44 foster youths, including junior counselors.

SOAR provides essential academic support, on a case-by-case basis, to help ensure that SOAR youth's grade point average consistently increase, and that our young people pursue an educational course leading to the fulfillment of their life goals and a bright future.

62 SOAR youths received academic support during 2019 (15% more than planned).

Summer Internship Program

In 2018 SOAR launched our newest service offering, an internship program to motivate and reward our academically successful summer program graduates. To qualify SOAR students must be 16 or older, in high school or the first 2-year of college, and an accumulated GPA of 3.0 or above. In 2019 we vastly enhanced our summer internship program to provide indispensable transportation assistance and to align the internships with our students' career goals.
