The first such project took place in 2019, and more detail of this activity is presented below. Part III Line 4a continued: project 1: CROSSED LINES, was THE FIRST IN A SERIES OF MULTI-SITED PUBLIC ART exhibitions in Grand Rapids, MI. Five international, national, and local artists created multifaceted installations, urban interventions, and community-oriented projects, exploring the lines that unite and divide a city, and what it means to belong. Amanda Browder created a large-scale vibrant fabric installation, turning building exteriors and other public sites into multi-colored structures. The largest and most ambitious section of her work, "Kaleidoscopic," was draped over the exterior of a community center building in Martin Luther King Jr. Park in Southeast Grand Rapids. The artist also wrapped four skywalks which link buildings in the heart of downtown. The final section covered the facade of a building at the Tanglefoot site on the southwest side of the city. Heather Hart created "The Oracle of the Soulmates" - twin rooftop sculptures, one in the center of Rosa Parks Circle in downtown Grand Rapids, the other on the lawn of MLK Park. Visitors could climb the rooftops and venture inside the attics, and the rooftops also featured a series of live performances. Olalekan Jeyifous created "The Boom and the Bust" - a monumental sculpture referencing the historic and contemporary challenges of housing discrimination and the inequities of urban life. This abstracted multi-story building form rose 25-feet from the ground at the corner of Louis St and Monroe Ave in downtown Grand Rapids. Paul Amenta and Ted Lott, known for their history of wide-ranging collaborative artistic productions with Site:Lab, presented "Critical Infrastructure" - a site-specific architectural intervention at the landmark Tanglefoot Building. The project reimaged the site by temporarily transforming a private space into a fully accessible public space, through a series of ramps and landings which welcomed visitors and a wide variety of performances and interventions by other artists. Rafael Lozano-Hemmer develops interactive installations that live at the intersection of architecture and performance art. For Project 1 by ArtPrize he created a new site-specific installation called "Voice Bridge." Along the handrails of Grand Rapids' iconic Blue Bridge - a pedestrian bridge which connects the East and West sides of downtown over the Grand River - visitors could find speakers and 400 lights that shone on the footpath of the bridge. Visitors could control the intensity of each light by speaking into the intercoms at each end of the bridge and recording a message. Once recorded, the message would play back as a loop - jumping from speaker to speaker across the bridge as more messages were recorded. THE FOLLOWING ARTWORK FROM previ
