Media & Communications - In 2019, CLI hired its first communications staff member due to the growing demand for its scientific and statistical commentary. CLI staff and its more than 60 issue experts were quoted more than 360 times by major news outlets, including The Washington Post, Washington Examiner, National Review, Daily Caller, CNN, Foxnews.com, and Townhall.com. The Members of the CLI team were also featured on a total of 30 radio and television programs, and wrote 16 op-eds, including ones placed in the Washington Examiner, National Review, Public Discourse, and The Daily Signal. In 2019, CLI published 11 policy papers on its website and had six scholarly papers published in peer-reviewed journals. CLI's social media engagement and reach also increased due to its dedicated communications staff. CLI launched a new website focused on reaching women seeking chemically-induced abortion, to educate on its harms, facilitate self-reporting of complications to the FDA, allow for sharing of their experiences with chemical abortion on the site, and provide a one-click-away connection to the Abortion Pill Rescue Network. CLI also provided media support for the Trump Administration's "Protect Life Rule". CLI information bolstered the Administration in the run-up to the new rule, building on CLI staff members' historic research on the purpose of Section 1008 of PHSA Title X.

Form 990, Part III, Line 4b:

Issue Advocacy and Education - In 2019, The SBA List Education Fund launched advocacy and educational efforts on a number of different issues related to the pro-life movement. These efforts included direct lobbying and grassroots lobbying, where applicable, with particular focus on expansion of public support for pregnancy help centers that prefer and support the choice to carry babies to term. The organization continued to support the drafting and delivery of expert testimony, participating in 23 legislative testimonies, including 16 at the state level and seven at the federal level. CLI conducted three full policy and science briefings on Capitol Hill, participated in a variety of state educational conferences, sponsored and submitted more than a dozen amicus briefs in federal court cases, and commented on the need for legal protections for infants born alive after abortion.

Data Analytics - In 2019 CLI's Data Analytics Department continued to produce independent analysis of issues in public health and maternal-fetal medicine. The Department made its first requests for data pulls from the Center for Medicare and Medicaid Services (CMS) for a series of 2020 studies on the impact of abortion on Medicaid patients' utilization of other publicly funded services. In 2019, we added eight associate scholars, with a range of experience in neonatology, obstetrics and gynecology, biology, and pediatrics.

Stem Cell Website - CLI continued to promote its long-term educational initiative on the benefits to patients of ethical, successful adult stem cells, derived without harming or destroying any human being. Adult stem cells remain the only stem cell showing validated success at improving patient health and saving lives, as we documented in videos featuring patients treated with adult stem cells, pioneer physicians who have used such treatments, and a peer-reviewed paper published March 2019 in the top-tier medical journal Circulation Research. CLI has also educated on the clinical success and research superiority of adult stem cells, organoids, and ethically derived humanized mice, compared to aborted fetal tissue. These points have been cited in media interviews, Congressional briefings, lectures, and op-eds. CLI scholars have produced an extensive academic review which will be published in a peer-reviewed journal in late Spring 2020. Our website, stemcellresearchfacts.org, and the videos featured there, have been powerful tools to educate the public as well as policymakers on the success of ethically derived scientific methods.

Coalition Building - As a research and education organization, CLI seeks to complement work being done by existing organizations, to create collaborative relationships and projects wherever possible, and to disseminate its findings and recommendations to a broad national, local, and international community. In 2019, CLI participated in many collaborations with various organizations, including the Center for Bioethics and Human Dignity, the Midwest Stem Cell Therapy Center, the Christian Medical and Dental Association, the American Association of Pro-Life Obstetricians and Gynecologists, the John Paul II Institute, the Elliot Institute, and The Heritage Foundation. Recommended scholars upon request for legal witnesses from nine states with pending lawsuits. Scholars submitted at least 11 written statements on their own behalf for six state cases (AR, IN, MO in two cases - UT and VA).

Pregnancy Center/Abortion Data Collection - CLI continued its comprehensive national project to promote improvements in the nation's public system for reporting the incidence of abortion and pertinent characteristics. To accomplish this goal, CLI published individual state reports and an overview of the most recent state-level data available, findings from which were recapped in The Washington Post. We continue to advocate for improvements in federal reporting by the U.S. Centers for Disease Control and to advise policymakers on information priorities. CLI maintained its contacts with U.S. pregnancy centers, advising on best practices, developing state-based coalitions for centers, and consulting with national and regional pregnancy center networks on the development of a national report on center accomplishments. CLI developed a number of new tools to assist states in tracking efforts to reduce abortions and build alternatives including financial and social resources for women facing unexpected pregnancies. These tools included a "clickable" map analyzing abortion trends in the 50 states and the District of Columbia and a new online tracker called Restoring Life in America that catalogs more than 40 key data points on topics from the birth rate, to adoption policy, to insurance coverage, accessing of prenatal care, and much else.

Legal Defense Fund - CLI maintained support for the Free Speech project launched in 2010. This project promotes freedom of speech on pro-life issues. Beginning in 2011, CLI made grants to a charitable organization that funds legal action against state laws that unconstitutionally restrict the freedom of speech of pro-life groups and other organizations in the public square.

Conscience/Health Care Alternatives - CLI continued in 2019 to make available information analyzing the impact of federal and state insurance exchanges on subsidies for plans that cover elective abortion. In addition to identifying policy remedies, such as enforcing the Affordable Care Act requirement of separate premium payments for abortion coverage, CLI worked with Family Research Council and co-researched and promoted, for the sixth consecutive year, ObamacareAbortion.com, a resource to inform the public which, if any, premium-subsidized plans in their state include this objectionable coverage before they decide to buy.
