The Assistance Fund (TAF) is an independent charitable patient assistance foundation that helps patients and families facing high medical out-of-pocket costs by providing financial assistance for their copayments, coinsurance, deductibles, and other health-related expenses. TAF assisted 50,071 patients in 2019, up from 36,157 in 2018 while also increasing their number of disease funds from 49 in 2018 to 61 in 2019. TAF improved visibility, scalability, service and accuracy by reducing its reliance on third parties and established an internal IT team. TAF's in-house patient advocate team increased from 26 in 2018 to 29 in 2019; handling approximately 166,000 phone calls. For other key employees, compensation is determined by the executive director after review of comparability data, including a salary survey. The information gathered and factors considered in arriving at the compensation is documented in the employees' personnel file. This process is performed on an annual basis.
