The vision of 1040i is to transform the lives of people in need by fighting pain and suffering in the most isolated places on our globe.
The primary focus is centered on health and education needs between 10 degrees and 40 degrees north of the equator spanning
across North Africa and the Middle East.

Projects and Trips: This is 1040i's largest program. In 2017 1040i conducted 2 trips to Cote d'Ivoire. The first trip in February had 61
North American volunteers. The medical team, which included 5 surgeons, performed 88 surgeries and treated 478 clinical patients.
They saw 339 patients in eye clinics and performed 42 cataract surgeries. The educational team built an additional dormitory for
younger students. The second trip in June had 18 volunteers, and they worked on renovating the Bilingual Academy and prepared
the classrooms for the following school year. There medical team conducted a prosthetic clinic, and 15 people were given the ability
to walk again with a prosthetic limb. There was a trip to Morocco for a women's health project with 12 volunteers during which 446
women were treated in the OB/GYN clinics.

Tanda Bilingual Academy: In 2014, 1040i enrolled students for first and second grade at its bilingual academy in Tanda, Cote d'Ivoire
with the goal to change poverty through education. This academy instructs in both French and English, now from 1st grade through
5th grade. Upon high school graduation students will receive a Cote d'Ivoire diploma. 1040i owns the academy
facilities, and oversees the staffing and operations of the academy. The academy was completed and began operations in 2014, and
now has 160 students enrolled. The academy instructs in normal primary and secondary educational areas, as well as technology.
Construction on the middle school began in 2018.
