We try to serve as many of these people as possible through our website, podcast, social media presence, weekly newsletter and on-line education courses.

The Creating a Family website, creatingafamily.org, is the focal point of the organization. We are almost entirely a web based entity. The website is our primary means of providing support and unbiased information to those dealing with adoption, foster care or infertility. The website averaged 85,000 unique visitors monthly. There is no charge for the vast majority of the information on the website. There is a charge for the On-line Education courses. (see below)

Creating a Family has developed over 100 courses on a variety of topics in the fields of adoption, forster care and infertility. These are one hour audio courses that can be accessed on a smart phone or computer. Participants can obtain Certificates of Completion by listening to a one hour video and successfully completing a quiz afterwards. In 2019, 16,700 courses were acquired.

Creating a Family also reaches out to individuals through its weekly newsletter to 4,800 subscribers and through its broad exposure to the social networks that it maintains on Facebook (over 9,500 followers on the Support Group page), Twitter (6,400 followers) and Pinterest (5,600 followers).
