TeamLift Inc. and St. Mary's Secondary School for Girls welcomed its final class of 150 new students, bringing the school to its full capacity of 600 students who are educated and board at our school. Lengthy negotiations with the Ministry of Health and the Christian Health Association of Malawi (CHAM) led to the design of a hospital to be built on the south end of the St. Mary's campus. A contract was negotiated with SITBEC Construction from Mzuzu, Malawi to build the healthcare facility and the work that began in 2019 will be completed in 2020. Teams of Capstone students from Oregon Health & Sciences University - the premier healthcare facility in Oregon - designed the administrative systems and protocols for the hospital. Capstone students from the University of Portland traveled with TeamLift to Malawi and designed an award-winning irrigation system for the seven-acre farm See Part III, Ln 4a statement
