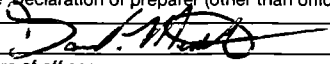

1) Contributions from Kodiak Electric Association members that elected to round up their monthly bill as a donation or elected to donate their capital credits to the KEA Educational Foundation. These donation totaled \$42,202

2) CoBank Sharing Success program. CoBank will match up to \$7,500 to 501(c)3 organizations. Kodiak Electric Association and Cobank each donated \$7,500 in 2019.

3) Investment income of \$19,447 was generated in 2018.

The KEA Educational Foundation awarded 30 scholarships for a total amount of \$62,454 in 2019
