This donation from Supernatural Marriage Ministries to Hope Mission of Vijayawada, India was used to construct three new church buildings. Hope Mission pastors teach married couples and single individuals the principles of establishing and maintaining healthy relationships. Much progress has been made in this area during the past several years. The divorce rate has dropped, and families are thriving because their interpersonal relationships have improved. These buildings are used throughout the year. They are constructed of durable materials and should last for many years.

4b (Code:) (Expenses \$ 55,300 including grants of \$) (Revenue \$)

These funds were donated by Supernatural Marriage Ministries to Amen & Amen Community Care Center near Kampala, Uganda. The money was used to complete construction of a two-story building that will be used as a dining facility for 400 orphans, a kitchen, administrative offices, storage and classrooms for high school level students. Some of the funds were also used to pay Amen & Amen staff salaries, purchase food for the orphanage, and upgrade the well & water handling system. All students at Amen & Amen are taught how to live successful lives, and encouraged to develop healthy relationships with others.

Supernatural Marriage Ministries donated these funds to Hope Mission of Vijayawada, India to provide support and education for children, young adults, and adults. They were given food, housing, clothing, and medical care. All were taught principles that will help them enjoy healthy and productive interpersonal relationships throughout their lives.
