BEPA CONTINUED ITS SUPPORT FOR THE BLUEFIELDS ANTI-LITTER PROGRAM, WHICH IS ADMINISTERED THROUGH THE BLUEFIELDS PEOPLES COMMUNITY ASSOCIATION (BPCA). BEPA PAYS AN HONORARIUM TO A TEAM OF "ANTI-LITTER VOLUNTEERS" WHO WALK THE MAIN ROAD FROM BELMONT TO MEARNVILLE PICKING UP TRASH THAT IS THROWN ON THE ROADSIDE. BEPA ALSO PURCHASES PLASTIC GLOVES AND PLASTIC BAGS FOR THE VOLUNTEERS, AS WELL AS TRASH RECEPTICLES. OTHER ACTIVITIES TO STRENGTHEN LOCAL COMMUNITIES: WE HAVE PROVIDED FOOD FOR DISTRIBUTION IN COMMUNITIES THAT EXPERIENCE HIGH RATES OF POVERTY AND HOST COMMUNITY GATHERINGS IN THOSE COMMUNITIES. WE ALSO PAID FOR MAINTENANCE OF PUBLIC LANDS, HELPED A LOCAL ORGANIC FARMERS ORGANIZATION WITH THEIR EXPENSES, AND COVERED BASIC COSTS FOR THE LOCAL POLICE DEPARTMENT. WE SUPPORTED SEVERAL YOUTH CLUBS IN THE COMMUNITY, AND PAID FOR SCHOOL SUPPLIES AND DOCTOR'S FEES WHEN INDIVIDUALS SHOWED SUFFICIENT NEED. WE ALSO PAID FOR REPAIRS TO THE LOCAL POLICE STATION THAT THE GOVERNMENT WAS UNABLE TO COVER.
