Invite Foreign Trainers for Teachers Development Training. The local Acehnese teachers will have regular trainings to improve their skills in teaching, especially approaches in handling children. These local Acehnese teachers will be sent out to different schools outside the village for exposure. The ESKWELA (preschool) was formed for community development purposes through education. Since the start of its operation in July 2009, an average of 60 to 70 children enrolled yearly. In 2019 almost 300 children were enrolled. This is a reflection that this community is in dire need of better education. Parents will secure their children's better future. Also this grant will be used to buy equipment as needed.
