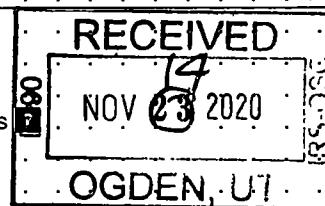

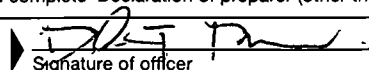

Grants paid of \$145,395 break down into three categories. Hardship grants which are awarded to families that are suffering from financial hardship due to breast cancer treatment that totaled \$137,950. Grant sizes are determined based on financial needs and set based on actual expense being incurred by the family. Grants ranged from \$500 to \$3,000. A total of one hundred and six grants were awarded in 2019. The second category is a yearly scholarship that is awarded to a student that has a parent or guardian affected by breast cancer. Each year a new student is awarded a 4 year renewable \$500 scholarship. Each year a total of \$2,000 in scholarship money is awarded 1 new scholarship and 3 renewals from previous winners. The third category are Well Wishes, which are small packages of flowers or edible arrangements that are given to women recently diagnosed or in treatment for breast cancer. The packages are designed to brighten the spirits of the women and families that might not necessarily have a financial hardship from their illness. The Well Wish packages range in cost from \$50 to \$150. Thirty-nine well wish packages were awarded in 2019 for a total of \$5,445.

Other expenses of \$32,701 are all fundraising expenses from our main fund raising event a charity ball and silent auction that takes place in the winter in Q1. Of which \$23,792 is the cost of the venue and dinner for the 500 guests. The remainder of the expenses are silent auction items, decorations, and miscellaneous items.

Total liabilities of \$2,500 are from awarded scholarships. Each year a scholarship is awarded and it is a renewable four year scholarship. The pending payments are accounted for as liabilities.
