




The Regional Program hosted the Regional Event for the winners of 10 hubs in Colorado, South Dakota, Oklahoma, Kansas, Pennsylvania, and Ohio involving schools with a total of approximately 790 student team members. This was our third Regional Competition which involved more teams and student team members and total attendees than in 2018. We also grew out of our donated facility which made it much more expensive than in 2018.

08. Part III, line 30

Our third largest program is the Teacher Mentor Institute Program. In this program, we expose the newer teachers to the BEST program, helping them understand how to mentor their students to a successful season. They learn about the software that is given to their teams, learn about all the parts of the BCST program, including a build of a robot, and the writing of an Engineering Notebook. The teachers / mentors receive 3 free days of training, and also Continuing Ed credits.

10. Part III, line 31

We have two other small programs, one that helps establish new hubs in the state, helping them get on their feet. When we find an organization or people who are interested in creating a Hub, we train them in what it takes to run a hub. We help them throughout their first season (and sometimes more). We sometimes co-host a Teacher Mentor institute with them, etc.

The second program is an outreach program to let educators, students, and parents know about Rocky Mountain BEST and its Robotics Competition.
