29 Opioid Practice Support - In 2019, NCHQA continued its work with Area L AHEC to implement an opioid practice support initiative that has been funded by The Duke Endowment. During this year, NCHQA and Area L AHEC continued to recruit provider practices in the Haliarx, Edgecombe, and Northampton counties to monitor opioid prescribing, ensure referrals to treatment and recovery resources, and implement Narcan co-prescribing for high-risk prescriptions. In this program, NCHQA convened state stakeholders to create pain management protocols and opioid patient safety materials to support health care providers in rural counties. NCHQA worked with Area L AHEC to convene community stakeholders to recruit providers and provide feedback on the protocols and opioid issues in Edgecombe, Halifax, and Northampton counties. Through this engagement of state and community stakeholders, NCHQA aims to support rural providers in reducing opioid prescribing and overdose deaths in their communities. With funding from the Health Resources and Services Administration (HRSA), NCHQA has collaborated with Area L AHEC, Freedom Hill Community Health Center, Rural Health Group, Vidant North, and other regional and community organizations to address the needs of individuals with opioid use and substance use disorder in the three counties. Our consortium and community stakeholders have identified ways to increase prevention efforts, improve medication-assisted treatment access in the region through the support of Federally Qualified Health Centers, have convened relevant partners to address peer and recovery access for individuals with opioid use disorder or substance use disorder, and have encouraged regularly, ongoing communication and collaboration between community and healthcare providers within each county and across counties. It includes individuals representing health care, consumer advocacy, public health and public policy, including the North Carolina State Health Director and NCDHHS Deputy Secretary for Medicaid. Each member brings a wealth of knowledge that continues to grow the organization by way of processes and procedures, strategic planning and fundraising. We continue to provide a trusted place where leaders from across North Carolinas healthcare system can work together to improve the quality of healthcare and the health of all North Carolinians. The mission and programs described in Form 990, Part III describe each programs accomplishments. In its first ten years of operations the organization has relied heavily on funding from a small number of sources, but is seeking opportunities to expand its base of support. We have continued to pursue funding from both governmental organizations and other public charities, focusing on governmental funding sources, in particular, that relate to our organizational mission and areas of current focus. We have been talking with state representatives to identify and understand any state funding opportunities available and are regularly monitoring federal funding opportunities.
