BioSand Filter Construction - Community Training: we offer community training programs in the construction of BioSand Water Filters. Each training is geared towards training 20-35 individuals in the production and safe use of BioSandd filters. The trainings are generally 5-6 days in length and covers both filter construction, as well as health and sanitation training. Along with the hands on construction training, FWWF provides multiple reusable steel molds (for filter construction) as well as tools and materials needed to produce filters for all the training participants. These are provided at no cost to the participants for their continued use. In 2019 we offered trainings in India, Democratic Republic of Congo, Kenya, Tanzania, Rwanda, Uganda, and Zambia. In 2019 FWWF conducted over 20 community trainings.
