Salaries of doctors and staff at the clinic in northern Uganda. Due to the civil war in South Sudan, the HKF doctors needed to transfer to northern Uganda to serve the South Sudanese refugees with medical services individually and through a clinic. The Healing Kadi Foundation raises funds to cover the salaries of the doctors, nurses, pharmacists, and other personnel who form our medical team. Although there were no specific gifts designated for salaries of the clinic personnel, the general funds and other fund-raising events covered the cost.

4b (Code _____) (Expenses \$ 38,090 including grants of \$ _____) (Revenue \$ 53,223)

Mission trips to the refugee camps in northern Uganda. A couple of smaller medical teams traveled to northern Uganda to set up clinic operations to serve the million plus refugees. This was a pass through amount as each participant paid their own way, but the money was channeled through HKF who made all the arrangements and paid all the expenses.

Medicine and Orphanage. Through several channels, medicine was purchased to take to Uganda on mission trips from money that was donated specifically for the purchase of medicine. Money was also donated to give to the orphanages in Uganda and South Sudan.
