THE SCHOLARSHIPS ARE DISTRIBUTED IN TWO PAYMENTS, IN AUGUST FOR THE FIRST SEMESTER AND IN THE FOLLOWING JANUARY FOR THE SECOND SEMESTER. THERE WERE TEN APPLICATIONS SUBMITTED TO THE FOUNDATION AND SCHOLARSHIPS WERE AWARDED TO NINE STUDENTS. AN APPLICATION FOR ONE STUDENT WAS APPROVED, BUT THE PARENTS DECLINED THE SCHOLARSHIP SINCE THE AMOUNT DID NOT MEET THEIR FINANCIAL NEEDS. ONE APPLICATION WAS DENIED AND ONE APPLICANT WAS DENIED SINCE IT WAS DETERMINED THAT THE FAMILY DID NOT MEET FINANCIAL NEED CRITERIA.STUDENTS ATTENDED TWO DIFFERENT SPECIALIZED SCHOOLS LOCATED IN JACKSONVILLE, FLORIDA AND IN SPECIALIZED SCHOOLS LOCATED IN BOCA RATON, FT. LAUDERDALE AND MIAMI, FLORIDA. THE APPLICANT'S SCHOOL MUST BE ACCREDITED AND MEET THE EDUCATIONAL NEEDS OF THE DYSLEXIC LEARNER.EVALUATION OF THE STUDENT'S COURSE WORK AND GRADES IS REQUIRED FOR CONTINUED SUPPORT SINCE SCHOLARSHIPS ARE FOR A ONE-YEAR PERIOD AND AN APPLICANT MUST RE-APPLY EACH SCHOOL YEAR.
