



Education: Educational outreach educate the public and consumers on distributed wind energy. DWEA has maintained its website and developed other products to accomplish educational goals. DWEA exhibited at a solar show to educate the public on the benefits of distributed wind energy. DWEA also held an event in Washington, DC to provide educational content to its members and other interested parties. DWEA participated in briefings for Congressional staff for education on agricultural applications of distributed wind energy.

Wind for Schools In conjunction with the U.S. Dept. of Energy and the National Renewable Energy Laboratory, DWEA is creating a sustainable program for the Wind for Schools (WfS) program to address the need to educate the next generation of wind workers. Twelve university-based Wind Applications Centers are established to engage college students by having them conduct classroom studies, field assessments and installations of small wind turbines at rural schools. Additionally these centers engage in teacher training, collaborated with Kidwind challenges, and evaluated data from the installed turbines. To date, more than 350 turbines (more than 40% of which are directly attributable to the WfS program) have been installed at schools.
