WISER GIRLS SECONDARY SCHOOL- WISER PROVIDED FULLY FUNDED SECONDARY EDUCATION, SAFE HOUSING, LEADERSHIP OPPORTUNITIES, SKILLS DEVELOPMENT, MENTORSHIP, AND PSYCHOSOCIAL SUPPORT TO 210 GIRLS, APPROXIMATELY 38% OF WHOM WERE HIV/AIDS ORPHANS IN 2019. WISER PROVIDED ALL THE TOOLS AND RESOURCES THOSE GIRLS NEEDED TO THRIVE, INCLUDING CLOTHES, BOOKS, MOSQUITO NETS, HEALTHY MEALS, CLEAN WATER, AND ESSENTIAL HEALTH RESOURCES. IN 2019, 100% OF WISER STUDENTS WERE PROVIDED ACCESS TO MENSTRUAL PADS, HIV TESTING, AND ONE-ON-ONE PSYCHOSOCIAL GUIDANCE AND COUNSELLING. WISER IS PARTICULARLY DEDICATED TO STEM EXCELLENCE AND PROVIDED ALL 210 STUDENTS WITH ACCESS TO A COMPUTER LAB, ROBOTICS AND ENGINEERING CLUBS, AND TWO UNIVERSITY-QUALITY SCIENCE LABS WHERE WISER FACULTY TEACH USING HANDS-ON LEARNING.

WISER COMMUNITY OUTREACH- WISER PROVIDED SEXUAL AND REPRODUCTIVE HEALTH (SRH) EDUCATION AND TRAINING TO NEARLY 1,800 COMMUNITY MEMBERS IN 2019, WHILE MAINTAINING A SPECIAL FOCUS ON ADOLESCENT SRH. NEARLY 1 in 5 OF ALL WISER STUDENTS WERE INVOLVED IN THE LEADERSHIP AND PLANNING OF THIS SRH OUTREACH. WISER OPENED ITS CAMPUS TO 615 COMMUNITY MEMBERS OF FREE HEALTH SERVICES EVENTS THAT INCLUDED: STI, HIV, TB, AND MALARIA SCREENINGS AND THE PROVISION OF FREE ANTIBIOTICS AND ESSENTIAL MEDICINES, EYE CARE AND THE PROVISION OF EYEGLASSES, AND HPV AND CERVICAL CANCER EDUCATION.
