TRANSFORMATION PRACTICE - THE TRANSFORMATION PRACTICE FOCUSES ON DESIGNING SOLUTIONS TO EMERGING DEVELOPMENT AND HUMANITARIAN CHALLENGES, AND WORKING TO EQUIP INSTITUTIONAL PARTNERS WITH THE TOOLS TO TACKLE 21ST CENTURY CHALLENGES. IN 2019, TRANSFORMATION WORKED WITH THE INTER-AMERICAN DEVELOPMENT BANK, UNICEF, ROCKEFELLER, OMIDYAR NETWORK AMONGST OTHER PARTNERS TO DESIGN FUTURE-FACING SOLUTIONS AND EXPERIENCES TO SUPPORT THE POPULATIONS THEY AIM TO SERVE. THE AMPLIFY PROGRAM WAS A 6-YEAR PROGRAM WITH A SERIES OF EIGHT OPEN, ONLINE CHALLENGES AIMED AT TRANSFORMING INTERNATIONAL AID THROUGH INCREASED COLLABORATION, FLEXIBLE FUNDING, AND HUMAN-CENTERED DESIGN. FUNDED BY THE UK DEPARTMENT FOR INTERNATIONAL DEVELOPMENT, AMPLIFY SOUGHT TO INSPIRE, IDENTIFY AND SUPPORT INNOVATIVE SOLUTIONS TO ISSUES FACING COMMUNITIES ACROSS THE DEVELOPING WORLD. AMPLIFY COMMITTED NEARLY \$5.4 MILLION ACROSS 46 GRANTEEES IN 19 COUNTRIES. EARLY PROTOTYPES OF NEW SOLUTIONS CREATED WITH THESE GRANTEEES ARE REACHING MORE THAN 1.8 MILLION INDIVIDUALS TO DATE. THE AMPLIFY PROGRAM FINISHED IN JULY 2019. SPECIAL PROJECTS RESEARCHED OPTIONS TO DEVELOP AND LAUNCH A LAB TO ACCELERATE MODERN CARE SOLUTIONS.
