They also must submit a complete, signed application. Once STM has all this information they evaluate the needs of the patient. Stomp the Monster can assist with rent (as long as the patient provides a signed, legal copy of a lease), household bills such as utilities, phone, cable (as long as they submit a copy of a current bill in their own name), auto expenses (car payments/insurance payments), medical bills or insurance bills. They can also provide gift cards for groceries or gas. The maximum grant for NJ residents is \$500 and \$400 for NY residents. If the need arises for a larger grant, it would require a board vote.
