All funds for our grants come directly from program fees that we charge international students and volunteers (college students in the USA)

The students participate in study trips and volunteer projects and a portion of their fees finances a grant to carry out a community project in Ecuador. In exchange, the communities provide Room/Board to the students/volunteers during their time in country.

COMMUNITIES AND PROJECTS:

A. LA MARISCAL. Located in the Amazon Region of Ecuador. Total Investment: \$7,180. Community members and students worked on

2 projects: i) an educational program that explored issues of gender among community members. Short educational dramatic plays created and later presented in neighboring communities. ii) Community-based tourism. Direct beneficiaries (DB): 30, Indirect beneficiaries (IB): 350

B. TZAWATA: Located in Amazon region of Ecuador. Total Investment: \$9,062. Community members and students worked on two projects:

i) a women's empowerment project development course that resulted in a \$3,000 investment into a women-operated convenient store, and

ii) a youth empowerment storytelling workshop designed to assist in identity formation and improved self-esteem. DB: 25, IB: 80

C. BAVOROE. Located in the Amazon region of Ecuador. Total investment: \$2,640. Community members and students worked on workshop

on Indigenous "ways of knowing," later presented at a local university in Quito. DB: 12, IB: 200.

D. PORTAL DE GUAJALO. Located in South Quito. Total investment: \$5,349. Community members and students worked on two projects:

i) a small-scale recycling and compost project & ii) an arts project designed to promote community unity. DB: 14, IB: 55.

E. QUITO ETERNO. A community-based organization located in Old Town Quito. Total Investment: \$3,349. Community members and

students worked on narrations to assist Quito Eterno with its capacity for cultural education programming. DB: 18, IB: 150.

F. PINTAG. Located in the Andes mountains of Ecuador. Total Investment: \$12,510. Community members and students worked on 2 projects

i) arts-based conflict transformation programming to assist with post-National Strike reconciliation. and ii) recuperating traditional agrarian practices via permaculture and storytelling. DB: 35, IB: 350.

EXPENSES: Other expenses.

A. Travel expenses for students and volunteers. \$11,920 - This includes the costs of transporting students to the communities and all their expenses when not in the partner communities, including additional food, lodging and cultural activities.

B: Materials. \$2,155. This includes the supplies that we purchase in order to carry out the educational programming during the projects.

C. Promotional trips. \$3,454 This includes all our travel expenses to colleges in the USA where we promote our programs

D. Facilitator expenses. \$2,180 This includes the travel, food, lodging and communications (internet, cell phone) for program coordinators.

Part IV: Officers, Key Employees, etc.

La Poderosa is operated by volunteers; however, three officers are also compensated as independent contractors in Ecuador in order to carry out the logistics of our programming. Each one uses legally registered Ecuadorian invoices to request payment from La Poderosa.

In addition to Daniel Bryan, Chelsea Viteri and Daniel Acosta, La Poderosa contracts a half-dozen other facilitators for minor programming.

Part V: Other information.

Line 33. Changes from previous tax years. Increased programmatic activity from 2017 to 2018 resulted in a 50% increase in receipts and declaring 2018 with the 990EZ (previously, receipts under \$50,000 allowed us to use the 990N). In 2019, receipts increased another 50%.

The increase of programming also resulted in contracting additional local project coordinators in Ecuador and covering their expenses.

Nevertheless, our organization is still very small and we have no need for fulltime employees. This will continue in 2020, however we anticipate significant contraction due to COVID-19.

Line 42a. Address. We remind the IRS that our organization is constituted in Minnesota, where we fulfill our legal reporting requirements; however, our team is a group of volunteers who live in different parts of the USA, as well as in other countries.
