IN 2019, ISF GRANTED \$50,015 HELPING 274 CREATURES, INCLUDING DOGS, CATS, HORSES AND OTHER FARM, EXOTIC AND WILDLIFE ANIMALS. TO DATE, 1181 GRANTS HAVE BEEN AWARDED AND MORE THAN 2,450 ANIMALS HAVE BEEN HELPED AS A RESULT OF THE PROGRAM. AS ALWAYS, EACH ANIMAL'S JOURNEY SHOWED US THE TRUE MEANING OF STRENGTH, LOVE AND WILL, FOR BOTH MAN AND ANIMAL. COLLEGE/YOUTH RELATED ISF GRANTS: \$7,000 TO CONNECTER IN SUPPORT OF THE GIRLS IMPACT THE WORLD FILMFESTIVAL AND THE GREENIS AWARD IN WHICH HIGH SCHOOL AND UNDERGRADUATE COLLEGE STUDENTS SUBMIT 3-5 MINUTE SHORT FILMS THAT EITHER PROPOSES SOLUTIONS TO ENVIRONMENTAL ISSUES THAT IMPACT WOMEN AND GIRLS, OR CREATE AWARENESS ABOUT ENVIRONMENTAL ISSUES THAT IMPACT WOMEN AND GIRLS.
