In December 2010, the property was once again reverted to the ownership of the SSF after the Diocese of Lafayette determined that it no longer desired to own the Holy Rosary Property. In order to redevelop the property, SSF conveyed the property to a separate entity. Holy Rosary Land Holdings Inc (Holy Rosary) operates solely for the charitable purpose of redeveloping the property educational purposes and surrounding community needs. The commercial strip mall is used for the upkeep of the deteriorating property. Holy Rosary continues to work with the community to bring the property back into service. SSF relied on the advice and counsel of their attorney, who established Holy Rosary as a nonprofit to own the property. SSF was not aware that additional filings were required or that the attorney had not filed all of the necessary documents to ensure that Holy Rosary was tax exempt. SSF, through Holy Rosary, have owned and operated the property in the same way it was owned and operated before it was transferred to the Diocese.</p> |
