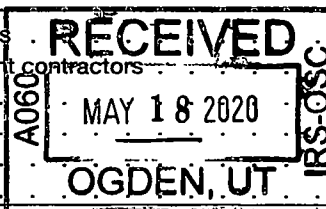

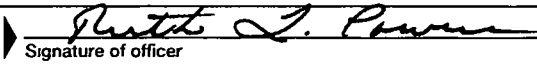

Grants made in 2019 totaled \$150,277. The grants were made to the Heather Chimoga Orphan Center in Zimbabwe. Grants are generally made via wire transfer to the bank account of HCOC in Zimbabwe. ZMP has ran significant influence over how the funds are distributed, but it does not have signing authority over the local bank account. Thus grants are not made directly by ZMP to vendors, workers, schoools etc.

The "other" expenses in 2019 of \$19889 were associated with with ZMP's primary fund raiser, a bicycle event - as well as a new endeavor, a golf tournament.

The amount on this line has been designated for a special project but was not spent in 2019. In order to keep track of this commitment - while still using cash accounting - we account for it as a liability as it will be spect as promised in 2020.
