The mission of Autistic Women & Nonbinary Network (AWN) is to provide community, support & resources for Autistic women, girls, nonbinary people, and all others of marginalized genders. In fulfillment of our mission, AWN self-published 2 anthologies: All the Weight of Our Dreams: on living racialized autism & What Every Autistic Girl Wishes Her Parents Knew. The latter has been picked up by Beacon Publishing for republication in 2021. AWN hosts educational events, autism acceptance events, seminars and conferences with the focus on multiply marginalized disabled people, book readings and discussions centering on autism and disability, and social gathering meetups which provides community connection. AWN sponsors a fund which provides direct financial support to autistic people of color through micro-grants.

28 Our programming focuses on educational events and activities to include autism acceptance events, conferences, panel discussions & meetups. The Autistic People of Color Fund (APOC) provides direct financial support to autistic people of color through individual microgrants wherein \$17,727 in grants helped over 100 families in 2019 with medical bills, student tuition and supplies, healthcare, housing, and much more. AWN also supports Autistic and disabled community members who run Neurodiversity Lending Libraries. We provided \$2,325 in grants throughout 2019 to assist these libraries with books, materials, as well as events in their local communities. We provide, as well as support to autistic speakers to attend forums and speaking panels to provide education centering disability, ableism, sexism, and racism by promoting diverse and intersectional spaces. Over 5,900 people benefited from in-person events with over 15 disabled activists receiving \$5,484 to assist with participation.
