ODZALA-KOKOUA NATIONAL PARKS IN THE REPUBLIC OF CONGO IS SITUATED IN THE HEART OF THE SECOND-LARGEST TROPICAL RAINFOREST IN THE WORLD, HARBORING APPROXIMATELY 22,000 WESTERN LOWLAND GORILLAS, ELUSIVE FOREST ELEPHANTS AND 444 BIRD SPECIES. BENEATH THE CANDESCENT CANOPY, AN UNPARALLELED LEVEL OF FLORAL DIVERSITY CREATES A BREATH-TAKING LANDSCAPE IN WHICH SOME OF THE PLANET'S RAREST AND MOST ENIGMATIC SPECIES CAN BE FOUND. LOCATED IN THE CENTRAL AFRICAN REPUBLIC (CAR), CHINKO IS A UNIQUE AREA THAT SPANS A VAST 17,600 KM2 WHERE SAVANNAH AND TROPICAL FOREST COLLIDE.
