ABOH is hosting the first of its kind online, animated patient education program at www.youandlungcancer.com, also available in Spanish at www.ustedycancerdepulmon.com. The beauty of this program is its ability to overcome barriers of education and medical illiteracy to educate lung cancer patients and their family members - no matter their learning style. Another component of ABOH's support programs is its Ambassador program, which provides transportation, companionship visits and support groups for patients, as well as an annual patient summit with high level education directed at patients and caregivers living with lung cancer. ABOH is also hosting a local, quarterly grief group for families who have lost a loved one to lung cancer.
