In 2019, The Warrior Connection (TWC) continued to witness fantastic success stories from each of our graduate groups, male and female veterans, and military spouses. Successes included graduates who shared joyous reunifications with family, graduates who opened their own business after six years of stagnation post service separation, while another family re-committed to their marriage, and re-engaged in their roles as parents after both veteran and spouse completed our programs.
