Explanation: This 2019 filing is late because of the Covid impact and the CANCER SURGERY of our principal leader. Our gross revenue is down now to only 25% of its former revenue in 2013. In the winter months of 2020, we had to postpone our Youth Symphony Division since and could not restart this fall. Our Alba Music Festival was canceled and the program service income REFUNDS will show up in 2020 return. The Cancer Surgery of our Director was in July and the recovery period was throughout the summer and fall. Currently, there is only \$2.40 (two dollars and 40 cents) in the Orchestra's account. We were unable to engage any part-time workers or professional accounting help in this period. We know that the IRS filing is a most important responsibility, but the Pandemic and Health issues were life-threatening distractions. We hope that you will offer understanding and forgiveness.
