Coastal Quest received a reimbursement grant from California Ocean Protection Council and Coastal Quest needed to pay in advance 14 small grants for collaboratives. California Ocean Protection Council's grant has a 10% contingency hold, and David Meyers provided a loan at fair market rate to cover the small grants made to the 14 collaboratives. The remaining \$14,000 balance due on the principal was repaid to David Meyers in 2019. In 2019, Tegan Hoffmann was Vice President at ERG, Inc. This company provides services to many clients including Coastal Quest, which paid ERG for staffing services in 2019 under the resource sharing agreement between the parties, at no profit. The resource sharing agreement was approved by the Board of Directors with Tegan Hoffmann abstaining from the vote, as she was an ERG employee in 2019 and Executive Director of Coastal Quest.
