EACH YEAR, SEVERAL HUNDREDS OF PERSONS MAKE ALIYAH (EMIGRATE) TO ISRAEL TO ESCAPE PERSECUTION, OPPRESSION OR POVERTY OR TO SEEK RELIGIOUS FREEDOM. MANY DO NOT SPEAK HEBREW OR ENGLISH (ISRAEL'S MAJOR LANGUAGES) AND MANY HAVE NEVER BEEN EXPOSED TO, AND THEREFORE DO NOT UNDERSTAND, THE BASIC OPERATING TENETS OF WESTERN SOCIETY OR DEMOCRACY.
