Hand of Hope is an organization dedicated to making a difference in the lives of people in southern Ethiopia and Kenya through orphan care, aid to the poor and evangelism. During 2019 we provided support to 40 orphans in southern Ethiopia as well as 22 orphans and 25 impoverished children in northern Kenya by providing financial assistance for their education, food and clothing. Hand of Hope partnered with local churches in Ethiopia to provide pastor training and sent one team from the USA to Ethiopia to visit 6 partner churches and meet with 15 evangelists to encourage them in their work. Additionally, Hand of Hope sent a team to Kenya in July 2019 to hold a Women's Conference and continued on to Golole, Kenya to visit Mwangaza Top View Academy and children in the area that Hand of Hope provides educational assistance for. Hand of Hope continues to build a relationship with this exceptional school that provides an excellent educational opportunity for impoverished children.
