To strengthen the system of fire and emergency services in San Diego County. The Foundation seeks strong & effective emergency services to provide quality fire protection and emergency services throughout San Diego County; to give fire and emergency service providers access to basic equipment, training and training materials; to facilitate multi-jurisdictional coordination and cooperation; and to educate citizens about fire preparedness & safety precautions they can take & about the system of fire & emergency services.

To provide the basic fire and medical equipment and training needed by firefighters, the Foundation conducts an annual grant program for all fire stations in the County with volunteer/reserve firefighters. These stations are first responders protecting over 60% of San Diego County. They respond to about 6,000 emergencies annually, about 5,000 of which are medical/rescue calls. To prevent the major wildfires of 2003 and 2007, these departments must have the necessary equipment and training to respond quickly and effectively extinguish fires while they are small, in spite of strong winds, heavy fuel and steep rough terrain in San Diego County. Medical equipment and training are critical as all volunteers firefighters are EMTs (some are paramedics) and generally will arrive and treat patients for 15 to 60 minutes before an ambulance, other medical personnel or a rescue helicopter can arrive on the scene in many rural parts of the County. The medical care provided in the field by these firefighters is critical for the survivability of some patients and the speed and degree of recovery of other patients.

4b (Code:) (Expenses \$ 36,129 including grants of \$ 0) (Revenue \$ 0)

After the devastating fires of 2003 and 2007, the County of San Diego engaged the services of an independent consultant to study fire services in the County. The consultant's recommendations included having the Fire Foundation take the lead in increasing public awareness about the system of fire protection and what responsibilities individual citizens have in fire prevention and preparedness. This awareness is critical given the high loss of lives and properties in these two major fire storms. The Fire Foundation has created a web site with information about fire prevention and preparedness and safety precautions individuals can take personally. The Fire Foundation also produces a periodic newsletter containing safety tips, accident and fire prevention information, and updates on fire and safety events occurring in the community.

4c (Code:) (Expenses \$ 34,129 including grants of \$ 0) (Revenue \$ 0)

As a result of the Consultant's recommendations, the Fire Foundation has been working with the newly formed County Fire Authority and CalFire to effectively form a County Fire Department with 42 fire stations with volunteer, reserve and career paid firefighters. To make this a reality, the Fire Foundation has been working to obtain communications equipment to insure all departments have the same level of equipment to expedite dispatching, reduce response times, have needed up-to-date mapping, and work together as effectively as possible. The Fire Foundation is coordinating with individual fire stations, the County and State to help make sure all equipment is available on all fire and rescue apparatus. To make this consolidation successful, the Fire Foundation is taking both a regional approach to communication and fire/medical equipment needs as well as unique station-by-station review of needs.

Annually the Fire Foundation conducts a grant program where all eligible fire agencies in San Diego County can submit a request for funding for equipment or training. The Foundation then seeks donors to contribute and fund these grant applications. If a donor specifies that their donation is to go to fund equipment at a specific fire department, that request is honored.

For all other funds where the donor has not specified which department or equipment they wish to fund, the Fire Foundation Board prioritizes the remaining grant applications and funds as many as possible. The Fire Foundation requires all fire agencies receiving a grant to supply receipts or other supporting evidence that the grant funds were expended as set forth in the grant. Failure to provide the required documentation causes that fire department to be ineligible for future grants.
